Contractor's who have not worked with Chatham County and Sandra Ridley, Consultants will be required to submit these credentials and Contractor Registration Application prior to any contract award. All Contractors' are subject to performance and credit evaluations. Chatham County reserves the right to reject any or all bids. Chatham County is an Equal Opportunity Employer.
