



# FINAL NOTICE

## DUE UPON RECEIPT

### IMPORTANT INFORMATION

- NOTICE OF DEBT SETOFF:** As authorized by NCGS 105-A, the Debt Setoff Collection Act, Chatham County intends to submit this unpaid debt to the NC Department of Revenue for collection by applying the debt against any income tax refund that you may be entitled to. Also, be further advised that in accordance with the Act, a local collection assistance fee of \$15 will be added to the account if it is submitted for setoff. If you have a valid reason to appeal this action, you may submit a written request for a hearing with the Hearing Officer. Valid reasons for the hearing include filing the claim with bankruptcy or proof that you do not owe or are not responsible for this debt. Your request for the hearing must be submitted within 30 days from the date on this notice. Failure to pay this bill in full or to request a hearing within the 30 day time limit will result in the setoff process being started against your future refund.
- OTHER ENFORCEMENT ACTIONS:** This debt is also subject to wage garnishments, securing funds from your bank account, sale of vehicle and registration block.

- RETURN CHECK FEE:** A penalty in the amount of \$25 or 10% of the check, whichever is greater, will be charged for checks returned unpaid.
